ELECTIONS

ASA will have openings for Secretary and two board of director positions this fall. If you are interested, please fill out a consent to serve and upload your resume/CV by July 1, 2022. Voting will begin September 1, 2022 and will end on Friday September 23, 2022 at our fall meeting in Dallas, TX. Forms can be found on-line at the ASA website.



MEMBERSHIP

Our membership is stable and we are at 1678 current members. It is very important that ASA continues to retain members to move forward with the initiatives that move our profession forward. Obviously, obtaining the ability to approve and process continuing education is our number one priority as we continue to move ahead. ASA does have some exciting new ideas that will be coming soon.

FINANCES

Despite some significant lobbying, textbook and setting up the organization with a new management company, along with new website expenses, ASA had a positive year. The opportunity to work with other organizations, including NSAA, to seek surgical assistant legislation has been very helpful. Over the last several months, ASA has been able to field more legislative activities because of sharing these costs. We hope to continue these collaborative endeavors into the future.

It is my pleasure to report to you that the state of the Association of Surgical Assistants is strong at 1,765. Over the last year, ASA has been working with other organizations whose missions affect the role of the surgical assistant.

I would like to inform you of some ASA accomplishments and achievements since the last report.

LEGISLATION

OHIO UPDATE

Legislation in Ohio is still pending a final vote out of the House Health Committee. We are encouraged by the support of our Ohio ASA members who have stepped up and made efforts to contact their respective legislators and be present at the hearings. With the upcoming primary voting season, legislative efforts were placed on hold, but we are expecting the hearings to pick up after the primary season has ended. Our bill sponsors are hoping that the licensure bill can be voted out of committee and move forward to the House floor for a vote soon after.

MASSACHUSSETTS UPDATE

ASA has continued to work diligently to get our MA members back to work as soon as possible. We have undertaken meetings with the MA Department of Health and members of the Senate, along with other entities with respect to healthcare legislation in MA. All of our meetings have been very successful, as our licensure bill has now

been moved out of the Joint

Committee on Public Health and on to the Senate Ways & Means Committee. We will be meeting with those committee members on June 1 to discuss what will be needed to move the bill forward. We have no opposition to this initiative, so expectations are very high that we will get this accomplished!



2022 ASA NATIONAL ELECTIONS

ASA will hold elections for national officers on-line in 2022. The open positions include Secretary, and two board of directors

In order to vote, individuals must maintain their active membership status through September 23, 2022. Active membership status is predicated on the individual having a current credential as a CSFA or CSA.

Voting will open September 1, 2022 and close on Friday, September 23, 2022. Election announcements will be made on Saturday, September 24, in Dallas.

Most individuals have multiple email addresses. Voters will need to use their official email address that is in their ASA membership record in order to access the ballot.

If you are interested in running for a national office, you must submit a Curriculum Vitae and Consent to Serve by July 1, 2022. Or if you believe you would like to lend your expertise to a committee, you would need to submit a Curriculum Vitae and Consent
